

- OPNS delivered letters specific to each physician and their utilization of technology. The technology platforms encouraged for utilization are intended to coordinate care in an efficient and electronic fashion. We're available for any questions, but here is a quick reference guide to simplify the requirements!

#### What are the four areas of focus?

- IT Survey We pre-populate from your previously provided responses. Just review, change if necessary, or say you're all set!
- Registry -Yes, the EMR is home to the record. The Registry aggregates quality data from external encounters as well.
- DPRO Tight on time? This web-based tool can train new staff on PCMH/PCMH(N) initiatives and interpretive guidelines.
- eReferral We're organizing care. Tracking referrals efficiently and electronically. We've heard its easier from early adopters!
