If applicable, see arteriosclerosis of the extremities with complications such as rest pain/ulceration. Aorta ectasia and aneurysms w/o rupture codes do not map to a payment HCC either, e.g., I77.819 and I71.9.

Skin Diseases

Pressure ulcers, only stages 2, 3, 4, and unstageable, are included in the payment methodology. See codes under category L89- Non-pressure ulcers, see L97- & L98.4-. Also, if known, code the underlying condition like DM or arteriosclerosis.

Amputations

Hand & arm, see Z89.1- and Z89.2-, Leg, AKA, Z89.61-, BKA, Z89.5-, Ankle, Z89.44-, Foot, Z89.43-
Toe amputation status codes were removed from the payment methodology.
E.g, Great toe, Z89.41-, Other Toes, Z89.42-

Ostomies

All artificial openings impact the HCC models, see category Z93-

Transplants

Most of transplants impact the HCC models, see category Z94-

Codes with a dash (-), i.e., L89-, require additional characters. See codebook.
